



LAWS AT A GLANCE FY 2020

Founded by three women who lived in Loudoun County, LAWS was incorporated in 1984 under the name Loudoun Citizens for Social Justice and does business as Loudoun Abused Women's Shelter (LAWS). LAWS is a 501(c)(3) private nonprofit organization providing essential services to survivors of domestic violence, sexual assault, and child abuse. The mission of LAWS is to provide victims of domestic violence, sexual assault, and child abuse with safety, hope and empowerment services to live as survivors free from the effects of violence. LAWS' vision statement is as follows: We envision a community that is free of domestic violence, sexual assault, and child abuse.

In Fiscal Year 2020, LAWS' staff and volunteers:

- Touched the lives of **1,218** individuals through direct services and educated **36,163** individuals through prevention, outreach and awareness programs
- Provided **4,795** bed nights of shelter to **67** adults and **86** children at the LAWS Emergency Shelter
- Responded to **1,255** crisis hotline calls on the LAWS 24-hour Hotline
- Provided **674** adult victims of domestic violence with walk-in crisis services, support groups, advocacy, financial assistance and/or counseling through LAWS Domestic Violence Services, located at our Community Services Center in Leesburg
- Assisted **247** victims with legal services through LAWS Legal Services
- Provided counseling, advocacy, and/or support groups to **205** adult victims of sexual assault through LAWS Sexual Assault Services
- Helped **128** youth and children deal with abuse in their lives with counseling, support groups and advocacy through LAWS Youth & Children's Services
- Served **169** victims of child abuse through the Loudoun Child Advocacy Center
- Approximately **75** dedicated volunteers and Board members donated over **5,000** hours of volunteer service to help LAWS achieve our mission.

In FY20, LAWS raised **\$2,621,025** carry out LAWS' mission. Sources of funding included: government grants: \$1,489,871; Resourceful Woman Thrift Shop sales: \$172,703; and fundraising, donations and private grants: \$816,903.

In FY20, LAWS employed approximately **33** staff: **20** full time; **3** part time and **10** hourly employees. Hourly employees include night/weekend shelter staff and a clinical therapist. LAWS has a volunteer Board of Directors comprised of 10 individuals who provide leadership and oversight to the agency.

LAWS operates a 12-bed emergency shelter; a legal practice with two full-time attorneys; a 24-hour crisis hotline; five counselors; five advocates (including two bilingual advocates); a violence prevention program, community outreach services to reach underserved populations, a Domestic Abuse Response Team (DART) Coordinator; and the Loudoun Child Advocacy Center. LAWS also operates the Resourceful Woman Thrift Store.

LAWS' Milestones

1984: Three women founded Loudoun Citizens for Social Justice and began working on their first project: The Loudoun Abused Women's Shelter (LAWS).

1985: LAWS' shelter opened in 1985 to provide safe housing for women and children fleeing domestic violence.

1991: LAWS rented office space in Leesburg to begin providing services to women who were not residing in shelter.

1992: LAWS began providing legal services, making LAWS one of the first domestic violence programs in Virginia to provide free legal representation to victims.

1995: LAWS opened The Resourceful Woman Thrift Shop, accepting gently used clothing and household items to give to victims in need and to sell to the community.

1996: LAWS added Sexual Assault Services to its programs, providing Loudoun with a rape crisis center, in addition to a domestic violence program.

2001: LAWS Community Services Center opened at 105 East Market Street in Leesburg to provide victims with legal representation, advocacy, counseling, support groups, and other support.

2003: LAWS added a Spanish-speaking case worker to the staff to assist Spanish-speaking victims.

2004: LAWS renovated its shelter, installed a new septic system, and made many improvements to the property.

2005: LAWS, along with other community partners, formed the Domestic Abuse Response Team (DART), a Coordinated Community Response (CCR) to address domestic violence and to hold perpetrators accountable.

2008: LAWS opened the Loudoun Child Advocacy Center (CAC) in December, 2008.

2013: LAWS was awarded "Non-Profit of the Year" by Loudoun Chamber of Commerce's 2013 Small Business Awards.

2014: LAWS was awarded "Non-Profit of the Year" at the Loudoun Times-Mirror's 2014 Citizen of the Year Awards.

2015: The Loudoun CAC becomes an Accredited Child Advocacy Center by National Children's Alliance (NCA).

2017: LAWS received increased funding to grow the programming provided to victims of domestic violence and sexual assault. LAWS also trained community professionals on the Danger Assessment and began implementing the LAP.

2018: LAWS is a founding member of the newly created Sexual Abuse Response Team (SART) in Loudoun County. In addition, the Loudoun Board of Supervisors increased the DART Coordinator position to a full-time position.

2019: LAWS was awarded "Nonprofit of the Year" from the Loudoun Times-Mirror's 'Best of Loudoun' awards.

2020: LAWS started the Housing Option Program to provide Transitional Housing, Rapid Re-Housing and Other Assistance to Individuals in an effort to try to increase the number of survivors who can move on to their own safe housing after fleeing domestic violence.

LAWS is a member of the Virginia Sexual and Domestic Violence Action Alliance, the Loudoun County Domestic Abuse Response Team, the Loudoun County Sexual Assault Response Team, the Loudoun Human Services Network, and the Loudoun County Chamber of Commerce, Children's Advocacy Centers of Virginia and an accredited member of the National Children's Alliance.

LAWS is a proud member of the United Way of the National Capital Area (United Way # 8145, Combined Federal Campaign # 23867). LAWS is a 501(c)(3) organization and our Federal Identification Number is 54-1282756.
